Introduction

We note the technical subject matter of the Consultation, concerning the marketing of heterogenous seeds or plant material, and limit our comments to the proposed legislative changes in line with the remit and expertise of the Sub-committee. We wish to make the following general comments relevant to the Consultation and the potential next steps following the consultation exercise.

¹ Marketing of Organic Heterogeneous Material: consultation

We understand that the proposed legislative mechanism to be used to implement the second or third proposals detailed under the "Legislative options" in the Consultation would be through secondary legislation. We consider it is important that there is sufficient stakeholder engagement and parliamentary scrutiny of the final proposals and text of the proposed regulations following the Consultation.

It is important that there is clarity and certainty in the law in order that individuals and businesses can guide their conduct appropriately. Changes to the policy and legislative framework on this matter would merit an appropriate awareness raising campaign so as to make individuals and businesses aware of the revised legal position. This would be a particularly relevant consideration in relation to any proposed temporary measures, such as those described at legislative option three in the Consultation.

We also note the wider ongoing and prospective legislative reform relevant to agricultural practice in Scotland, including the Agriculture and Rural Communities (Scotland) Bill, which is currently at Stage 1.2 We highlight the importance of considering the interplay and overlap between such reforms to ensure a consistent and aligned approach across all policy and legislative developments affecting the rural and agricultural sector.
