## 1. Your details

Please insert the full name and address of the person who is claiming the money.

## 2. Name of solicitor firm being claimed from

Please insert the name of the firm of solicitors that you are claiming from.

#### 3. Your claim

a. Value of claim

Please insert the full amount being claimed for. If you do not know the full amount, please give a description so we can calculate this sum.

# b. Details of claim

Please explain why this sum was held by the firm, including the date it was incurred, and attach any documentary evidence.

### c. Details of any security

A security is a legal document which establishes ownership. If you hold such a document which relates to the claim, please provide details, including the date it was granted and the amount or value.

## 4. Other information

If you have any documents which you believe would help your claim, such as receipts or correspondence from your former solicitor, please send us copies and list them on the application form.

#### 5. Declaration

The claim form should be signed by the person claiming the money or their new solicitor. If the funds held by the firm were in a joint account (such as a husband and wife or a partnership) then both parties should sign. If the claim form is only signed by a solicitor, the money will only be paid directly to the client.

#### 6. Transferring the money to your new solicitor

If you wish to have the funds transferred to your new solicitor and not directly to you then you must also sign this section. This authorises the payment to be made to your new solicitor's firm.

If you want the money to go directly to you, you do not have to fill in this section.
